We are a research and development entity that operates and creates Artificial Intelligence technologies.

1. ABOUT THIS POLICY

1.1 Our site uses Cookies and analogous technologies to assist in recognising you when you visit it. Using Cookies enables us to provide a better experience to you and improve our site by better identifying how you use it.

2. DEFINITIONS AND INTERPRETATION

In this Policy the following words shall have the following meanings:

“Cookie”: a small file of letters and numbers placed on your browser or the hard drive of your Device by our site if you agree when you visit certain parts of our site and/or when you use certain features of our site and they contain information that is transferred to your computer's hard drive;

“Cookie Law”: means the Cayman Islands Data Protection Act (2021 revision) in force from time to time and as amended, and any successor legislation;

“Device”: your computer or device;

“Personal Data”: all data that relates to an identifiable person who can be directly or indirectly identified from that data, as defined by the Cayman Islands Data Protection Act (2021 revision) in force from time to time and as amended, and any successor legislation.

3. HOW DOES OUR SITE USE COOKIES?

3.1 First party Cookies are those placed directly by us and are used only by us. Our site may place and access certain first party Cookies on your Device. We use these to enable and improve your experience of our site and to provide and improve our services. We have chosen these Cookies carefully and taken steps to protect your privacy and Personal Data.

3.2 By using our site, you may also receive certain third-party Cookies on your Device. Third party Cookies are those placed by parties other than us. Third party Cookies are used on our site for advertising our services. For more details, please refer to section 4 below.



3.3 All Cookies used by and on our site are used in accordance with current Cookie Law. We may use some or all of the following types of Cookies:

3.3.1 Strictly Necessary Cookies

These are required for the operation of our site. These essential cookies are always enabled because our site won't work properly without them. You can switch off these cookies in your browser settings but you may then not be able to access all or parts of our site.

3.3.2 Analytics or Performance Cookies

These allow us to recognise and count the number of visitors and to see how visitors move around our site when they are using it. We need to understand how you use, navigate, and use our site to help us improve it and your experience of it. We use Analytics to do this.

3.3.3 Functionality Cookies

These are used to recognise you when you return to our site. This enables us to personalise our content for you and remember your preferences. Some of these may also be strictly necessary Cookies, although not all.

3.3.4 Targeting Cookies

We need to know when, how often and which parts you visit and use of our site (including which links you have used). As with analytics Cookies, these cookies help us to understand you and to make our site and advertising relevant to your interests. Some information gathered by targeting Cookies may be shared with third parties for this purpose.

3.3.5 Persistent Cookies

Any of the types of Cookies set out above may be a persistent Cookie. These remain on your Device for a predetermined period and activate each time you visit our site.

3.3.6 Session Cookies

Any of the types of Cookies set out above may be a session Cookie. These are temporary and only remain on your Device from the point at which you visit our site until you close your browser. These Cookies are deleted when you close your browser.

3.4 Except for essential Cookies on our site, all Cookies will expire after 12 months.

4.3 Our site may use analytics services provided by AWS, Google or similar. Website analytics refers to a set of tools used to collect and analyse anonymous usage information and help us understand how our site is used. This enables us to improve our site and the services offered through it. Our use of these does not pose any risk to your privacy or your safe use of our site but you do not have to allow us to use these Cookies. However, it does enable us to improve our site and your experience when using it.

4.4 The analytics service(s) used by our site use(s) analytics Cookies to gather the required information.

5. THIRD PARTY COOKIES

5.1 Third party Cookies are not placed by us, they are placed by third parties that provide services to us and/or to you. These may be used to tailor advertising to you on our site, or by third parties providing analytics services to us and work in the same way as analytics or performance or targeting Cookies. We have no control over third party Cookies.

5.2 These named third parties may include:

6. CONSENT AND CONTROL

6.1 You will be shown a pop up requesting your consent to set Cookies before Cookies are placed on your Device. You may, if you wish, deny consent to the placing of Cookies unless those Cookies are strictly necessary; however certain features of our site may not function fully or as intended. You can return to your Cookie preferences to review and/or change them at any time.

6.2 In addition to the controls that we provide, you can choose to enable or disable Cookies in your internet browser. Most internet browsers also enable you to choose whether you wish to disable all Cookies or only third-party Cookies. By default, most internet browsers accept Cookies, but this can be changed.
